CHAPTER 1

1 INTRODUCTION

1.1 The National Police Service

The National Police Service is a creation of the Constitution of Kenya 2010. Its mandate and functions are spelt out in the National Police Service Act 2011 and the National Police Service Commission Act 2011. To effectively perform its mandate, it is divided broadly into:

1. The Kenya Police Service,
2. The Administrative Police Service and
3. The Directorate Criminal Investigation.

As outlined in Part III, section 24 of the National Police Service Act, the functions of the Kenya Police are:

1. Provide assistance to the public when in need
2. Maintenance of law and order
3. Preservation of peace
4. Protection of life and property
5. Investigation of crimes
6. Collection of criminal intelligence
7. Prevention and deduction of crime
8. Apprehension of offenders
9. Enforcement of laws and regulations with which it is charged
10. Performance of any other duties as may be assigned by the Inspector General in accordance with the law

1.2 Personnel

As of 31st December, 2020 the total number of Police officers stood at 100,481; 86,663 being male and 13,818 being female officers. The officers were deployed as follows:

1. Kenya Police Service 61,165; 51,918 males and 9,247 females;
2. Administration Police Service 33,377; 29,612 males and 3,765 females; and
3. Directorate of Criminal Investigations has 5,939 officers; 5,133 males while 806 were female.

CHAPTER 2

2 CRIME ANALYSIS

This chapter looks at a whole range of criminal cases that were reported from January to December 2020. These criminal cases are categorized into seventeen (17) category of offences.

2.1 Annual Crime Comparison

During the period under review (January to December 2020) a total of **69,645** cases were recorded. This is a **25.4%** decrease from the same period in 2019 which recorded **93,411** cases. In 2018, police recorded a total of **88,268** cases which rose by **5.8%** or **5,143** cases in 2019. The 25.4% drop in cases witnessed in 2020 can be attributed to the lockdown measures that were implemented by the government in its bid to curb the spread of COVID-19 that was in effect from April 2020.

From the **69,645** cases reported in the subject period, Other penal code offences recorded the highest number of cases with **19,288** cases or **28%**. Under the category of Other penal code offences, Assault was the most reported with **14,046** cases followed by creating disturbance and affray which recorded **4,442** and **800** cases respectively. Offences against morality was the second most reported category with **9,153** cases or **13.2%**. Under this category, defilement was the largest contributor with **7,381** cases and other cases in the hundreds were rape (**939**), incest (**333**) and indecent assault (**287**). Stealing was the third largest category and it accounted for **13.1%** of all the cases or **8,709** cases.

Additionally, during the period under review, there was a decrease in every category of crime compared to the same period in 2019 except for homicide, offences against morality and corruption which recorded increases.

In the period under review, there were 31,717 reported cases as compared 44,950 cases in the same period 2019 which was a decrease of 13,233 cases or 29%. The number of persons reported to the police to have committed crime in the half year 2020 was 30,346 (25,362 males and 4,984 females). Total victims of crime in the half year 2020 were 25,689 (14,098 males and 11,591 females). 26.27% of all people reported to have committed offences were between the ages of 30 to 44years. The country recorded a crime index of 67 per 100,000 people.

2.2 Persons Accused of Committing Crimes and Victims of Crime in 2020

The number of persons reported to the police to have committed crime in the year 2020 was 65,083 (54,035 males and 11,048 females). Total victims of crime in the year 2020 were 55,159 (29,688 males and 25,471 females). The most crime committing ages was between the ages of 30 to 44years which had a total of 17,582 people reported to have committed offences. The country recorded a crime index of 146 per 100,000 people.

2.3 Offences

Assault offences reported to police accounted for 20.2% of all cases reported to police recording 14,046 cases. It was followed by general stealing with 7,602 cases, defilement 7,381 cases, other penal code offences 6,790 cases, creating disturbance 4,442 cases and possession of drugs (cannabis sativa) 3,575 cases. The least recorded cases were offences against tourists 1 case, accepting free gifts (police officers) 1, accepting bribes (police officers) 2, bag snatching (tourists) 3 and demanding by false pretense (government officers) 9.

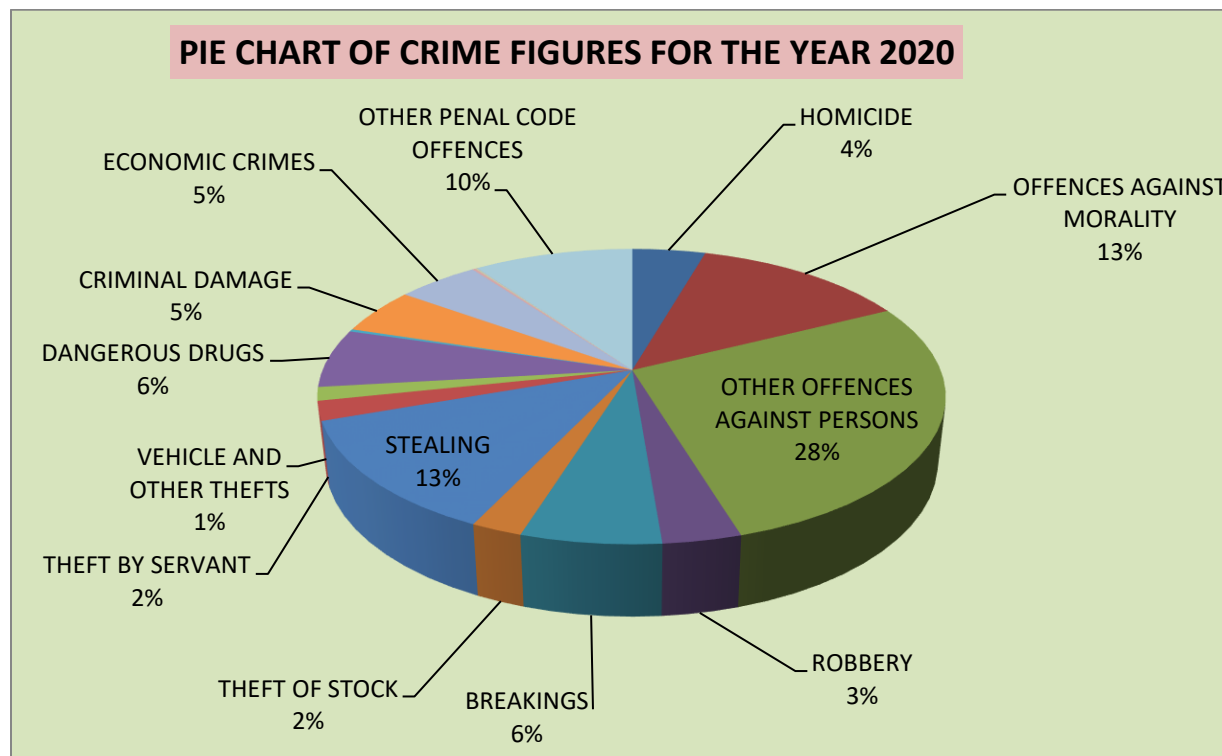


Figure 1: Pie Chart of Comparative Crime Figures for the Year 2020

2.3.1 Increases

Increases were noticed in 16 offences which include defilement by 1,204 (19.5%), affray by 181 (29.2%), murder by 163 (8.8%), stealing by directors by 80 (65%) and suicide by 47 (9.5%).

2.3.2 Decreases

Decreases were observed in 49 offences which include assault 4,963 cases (26.1%), general stealing 4,667 (38%), possession of drugs 3,133 (46.7%) creating disturbance 3,126 (41.3%), other penal code offences 1,884 (21.7%) and. (Appendix 1)

2.4 Regional Crime Analysis

Rift Valley region was the region with the highest crime recorded with **15,823** cases which was a decrease of **7,267** cases from the same period in 2019. Most of the cases reported in Rift Valley fell under the category of Other Offences Against Persons (**4,523**), followed by Offences Against Morality (**2,310**), Stealing (**1,881**), Other Penal Code Offences (**1,541**) and Breakings (**1,076**).

Eastern region was second recording **13,532** cases, a decrease of **4,384** cases or 7.6% with Meru County leading in terms of crimes reported to police at **4,163** cases. The category with the highest number of offences in Eastern region was Other Offences Against Persons at **4,005** cases.

Central region was third with **10,689** cases which was also a 26.8% drop from 2019. In Central Region, Kiambu County was the highest with **4,353** cases. It was followed

by Muranga county with **2,079** cases, Nyeri county with **1,482** cases, Kirinyaga with **1,452** cases and finally Nyandarua with **1,323** cases. During the period under review, all the counties recorded decreases in comparison with 2019.

2.5 County Crime Analysis

Nairobi County recorded the highest number of cases reported to police at **5,844**. The largest number of cases reported in Nairobi involved Offences Against Persons at **1,080** cases. The highest number of Assault cases reported (**902** cases) is an indication that most offences are between persons known to each other.

Kiambu County was second with **4,353** cases and Meru County third with **4,163** cases, majority of the cases being assault. Nakuru and Machakos were fourth and fifth with **3,492** cases and **2,842** cases respectively. Wajir County was the least recording a total of **243** cases.

All counties recorded decreases compared to 2019 except for Kisumu (202 cases), Lamu (41 cases), Samburu (17 cases), Garissa (10 cases), and Taita Taveta (3 cases) which recorded increases. (See Appendix 6 & 16)

2.5.1 County Crime Rate per 100,000 of the Population

A crime rate is calculated by dividing the number of reported crimes by the total population. The result is then multiplied by 100,000. For example, in the year 2020,

there were 6,9645 crimes in Kenya and the population is 47,564,296. This equates to a crime rate of 146 per 100,000.

Meru County had the highest crime index of **269** followed by Lamu **264**, Taita Taveta **253**, Embu **251**, and Kirinyaga **238**. The least crime index was recorded in Wajir with **31**, Mandera **35**, Garissa **59**, Narok **62**, and Kakamega **65** (See Appendix 5).

2.6 Monthly Crime Figures

The month of January had the highest number of cases reported recording **7,952** cases. It was followed by February with **7,638** cases and July with **6,948** cases. The least number of cases were reported in the months of April and May which recorded 2,276 cases and 3,562 cases respectively.

In comparison with 2019, increases were only recorded in January and February with **0.7%** and **5.9%** respectively. Decreases were recorded in the remaining months with April recording the highest decrease (**69%**) followed by May (**53%**), March (**37%**), September (**32%**), August (**31%**), and June (**24%**).

CHAPTER 3

3 THREATS TO NATIONAL SECURITY

Organized Crime

3.1 Terrorism

Terrorism continues to affect the North Eastern and Coastal regions because of their proximity to Somali. The militants continue to target security personnel by planting

improvised explosive devices and then shooting at them. These devices are mostly planted on routes frequently used by security personnel. The targeting of security personnel is partly due to the fact they have sealed loopholes used to move contraband goods originating from Somalia. An emerging mode also being employed by the militants is randomly shooting at security installations and communication masts. Non local teaching staffs in schools have also been targeted by the militants.

During the period under review, there were 34 terror related incidences reported; Out of the 34 incidences reported countrywide: There were 24 active shooter incidences; 10 in Garissa County, 7 in Mandera county, 4 Wajir county and 3 in Lamu County. 7 IED attack incidences were reported: 2 incidences in Wajir County and Mandera Counties respectively while Tana River and Garissa counties reported 1 case each respectively, 2 kidnapping cases were recorded in Garissa County and 1 attempted terror attack was recorded in Garissa County in the month of February 2020.

There were 33 fatalities: 21 civilians and 10 police officers (including 4 Police reservists) and 2 suspects, 57 people were injured during the terror attacks: 35 police officers and 22 civilians. 3 persons were kidnapped in Garissa County during the period under review.

Police Intervention

75 suspects were arrested during the period while 2 were fatally shot by security officers.

To counter terrorism, the Police held Joint Security operations that led to the recovery of weapons and arrests of recruits' en route to Somalia and their facilitators. County Action Plans (CAPs) on Counter Violent Extremism were also launched. There was sustained vigilance on online platforms that include Facebook, IMO and WhatsApp, mostly exploited by terror operatives to coordinate their activities. Patrols were increased along the borders, security coverage of communication infrastructures

enhanced and National Police Reservists recruited, armed and remunerated. (See Appendix 5)

3.2 Drug and Psychotropic Substances Abuse

Drug and psychotropic substance abuse continues to have a negative impact on health, social and economic wellbeing of the users and their families. The financial burden on the budget of the health sector runs into millions annually. The Coastal of Kenya has had to bear with a jobless youth who are addicted to different psychotropic substances. This eventually leads to them committing different crimes in an endeavor to sustain their addiction.

A total of 3,412 people (3376 Kenyans and 36 foreigners) were arrested for drug related offences that include possession, cultivation and trafficking. 2,786 of those arrested were found in possession, 536 were involved in trafficking while 90 were found cultivating. The highest number of arrests was in Nairobi with 332 followed by Muranga 268, Mombasa 260, Nakuru 245, Kiambu 141 and Kirinyaga 134. (See Appendix 7)

A total of 3,022 cases are pending before court, 380 cases are finalized and 10 are pending arrest of known accused.

A total of 2,644.85 sachets, 90 tabs, 10,909 kilograms, 94,218.9 rolls, 8,288 plants, 5,581 brooms, 991 stones and 142 pellets of different types of drugs were netted by Police.

The following drugs were netted in the country bhang, shisha, heroin, cocaine, cozepam tabs, stilnox and rohyphnol.

To address the menace, the police have expedited prosecution in collaboration with the Government Chemist and the Office of the Director of Public Prosecutions. There has also been adoption of the follow-the-money approach in investigations and prosecutions.

3.3 Contraband Goods

The presence of contraband goods in the economy is not only a threat to legitimate business but also a health risk to consumers. The National Police Service, Kenya Revenue Authority and Kenya bureau of standards are entrusted with the task of ensuring that no contrabands are smuggled into the country.

The National Police Service through the Northern Corridor Transit Patrol Unit (N.C.T.P.U) is mandated with security of imported goods on transit to other countries.

During the year under review, the following were netted 8,702 bags of sugar, 313 bags of rice, 278 boxes of alcohol, 27 tins of cooking oil, 60 boxes of spaghetti, 31 boxes of powder milk, 10 henna, 10 pharmaceutical boxes, and 1 box of meat tuna. Police managed to arrest 2 people. (See Appendix 6)

3.4 Organized Criminal Groups

Criminal groupings have been re-emerging in the following Counties. Nairobi (Tsunami group), Kiambu (Kamagira), Nakuru (Confirm and super striker) and Mombasa (Wakali Wao and Waroma)

Police officers managed to arrest and arraigned to Court a total of 396 suspects of organized groups with Nakuru county leading with 344 suspected.

To address this threat, the Government initiated and enhanced a number of measures which include intensified crackdown on the gangs, employment of drones to do surveillance along the riverbanks and banning of night entertainment during weddings because most female victims were found to be from night wedding functions.

3.5 Wildlife Security

Wildlife security in Kenya is characterized by international illegal trade in wildlife products, commercial poaching for bush meat and illegal wildlife trade. Human-wildlife conflict, bush meat trade and commercial poaching remain a threat to wildlife conservation in Kenya. While the illegal killing of elephants and rhinos for export trade in ivory and rhino horn has been widely recognized as a key threat, the rise of commercial poaching for bush meat is emerging as a serious threat to species survival, as well as affecting tourism in key protected areas. High levels of poaching coupled with illegal wildlife trade in the past have been a threat to species conservation in Kenya.

In the year 2019, 1,202 incidents of poaching were reported to police leading to arrests of 293 illegal grazing in the wildlife parks, 230 people arrested for having bush meat, 144 snare netted and 103 tusks netted.

Communal Conflicts

3.6 Cattle Rustling and Stock Theft

Cattle rustling and stock theft incidents has been rampant in most parts of the country especially amongst the pastoralist communities living in the North Rift counties. The menace is largely attributed to commercialization of cattle rustling, proliferation of small arms, competition for scarce natural resources, political activities, cultural beliefs and strive for ultimate territorial control. The rate of recovery has improved but the main challenge still remains the vast and harsh terrain in cattle rustling prone areas which hinders mobility of the security services in the area.

A total of **262** cases involving cattle rustling were recorded during the period under review as compared to **254** cases in the same period in 2019. This represents an increase of **8** cases or **3%**. A total of **32** people were killed and **47** others injured during the period under review in comparison to **48** killed and **58** injured during the same period last year. This denotes a decrease of **16** for those killed and **11** for those injured.

A total of **20,842** livestock were stolen and **13, 381** recovered compared to same period last year which had **13,404** livestock stolen and **6,574** recovered

respectively. This registers an increase by **7,438** livestock stolen and **6,807** recoveries. The major reason for the sharp increase in the number of cattle stolen during the period under review is the persistent drought that struck extensively the cattle rearing communities and regions. As a result of this, most raids were undertaken during the movements in search of water and pasture for animals, boundary disputes, negative politics and outdated cultural practices.

3.7 Land and Boundary Disputes

Land and boundary disputes have been reported in the Counties of Narok, Kitui, Taita Taveta Marsabit, Lamu, Tana River Isiolo and Meru. These disputes have been due to disagreements over grazing land, administrative boundaries and community feuds.

Other Threats to National Security

3.8 Proliferation of Illegal Firearms and Light Weapons

The effect of having illegal arms and ammunitions in the wrong hands in Kenya continues to be a matter of concern to security agencies. Pastoralist areas and major towns have recorded a high number of criminal incidences that are attributed to availability of illegal guns. Pastoralist communities who live in expansive areas that are sparsely populated are affected the most.

During the period under review, 167 firearms were recovered while 69 were surrendered, 1869 ammunitions were recovered while 2009 were surrendered and 13 explosives were recovered and 2 surrendered. (See appendix 7)

3.9 Influx of Illegal Aliens and Undocumented Immigrants

Illegal aliens and undocumented immigrants have been associated with human trafficking and smuggling of persons, as well as small arms and light weapons. They are also easy targets for recruitment into terrorist activities and other trans-national crimes, thus posing a threat not only to national, but also to regional security.

In the year under review a total of 1,640 aliens and undocumented were immigrants arrested all over the country an increase of 40% as compared to the same period in 2019 which recorded 1164 cases. The highest numbers of those arrested were

Ethiopians 807 and Somalis 306. Other aliens included Tanzanians 200, Eritreans 68, Congolese 53 and Ugandans 52. (See Appendix 8)

In an effort to deal with this challenge multi-agency operations along the main transport corridors used by aliens were carried out. Investigations and prosecution were expedited. These led to conviction of those engaged in crimes and subsequent deportation.

3.10 Illicit Brew

Consumption of locally brewed illicit brews continues to affect the productivity of Kenyan youth and at times affects their health. Some of the brew like Simba Waragi which finds its way into the Country from across the borders, packaged in easily portable and lowly priced sachets erodes the efforts multi agency teams have put in place to curb alcoholism. Consumption of such illicit brews has an effect on the health of the consumers and at times leads to death.

During the period under review, police netted a total of 324,564 litres of illicit brew and 1,063,248 litres destroyed. There were a total of 13,719 persons arrested where 1,877 manufacturers, 108 distributors, 5,777 retailers and 5,957 consumers were arrested. (See Appendix 9)

The increase in the number of arrests can be attributed to the multi-agency approach which involves carrying out of raids in collaboration with the National Government Administrative Officers.

3.11 Kidnapping

During the period under review, there were 21 kidnapping cases where Central Region recorded the highest number of incidents with 6 cases; followed by Nyanza and Nairobi with 5 cases each, Rift valley with 3 cases and North Eastern Region with 2 cases.

Most of the suspects are men but in cases of a juvenile victim there is always a woman suspect in case. Most of the victims are men where they get kidnapped and held hostage for ransom. It is observed that use of firearms and crude weapons is rampant. Adults are the most victimized and people with private vehicles. Most of kidnapping executions are done in day time because of the current pandemic (Covid-19) and curfew hours.

3.12 Police Officers Killed in Line of Duty

Police officers have been killed in cold blood, injured in the line of duty while others have been arrested as suspects in different criminal cases. The number of injured officers were high indicating that even those charged with protecting the public are themselves becoming victims, with the greatest cause being Road Traffic Accidents. (See Appendix10)

During the period under review, there were 84 police officers killed as compared to 2019 that had 62 cases making an increase of 22 cases.

A total of 1052 police officers were injured in line of duty as compared to 615 officers in 2019 where an increase of 437 was recorded.

A total of 193 officers were arrested during the period under review. 38 of these arrests were made in Rift Valley Region followed by Eastern with 33 cases, Central 32 cases and Nyanza 28 cases.

To deal with this the reorganization of the National Police Service was finalized. This reorganization involved assignment of protective, border security, combating cattle rustling and banditry functions to the Administration Police Service. The Kenya Police Service would therefore focus on public safety and security.

3.13 Road Traffic Accidents

Road traffic crashes continue to cause deaths and injuries to road users despite the Government’s effort to curb them. The major causes of road traffic crashes include:

speeding, overloading, drunk driving, fatigue, wrong use of the road by pedestrians, poor road infrastructure and non-observance of traffic laws.

During the period under review, there were 8,918 cases of road traffic accidents in 2020 as compared to 7170 cases in 2019. This was an increase of 1,748 cases or 24.4%. There were 3,514 fatal road traffic accident cases in 2020 as compared to 3,078 cases in 2019, being an increase of 436 cases or 14.2 %.

There were 3,975 fatalities in 2020 as compared to 3,586 in 2019, being a decrease of 389 fatality cases or 10.8%. 8,027 people sustained serious in 2020 compared to 6,953 people in 2019, while 4,968 people sustained slight injuries in 2020 as compared to 5,208 persons in 2019. The total number of victims increased by 1,223 cases or 8%.

The total fines collected decreased from Ksh. **556,588,630/=** in 2019 to Ksh. **131,289,830/=** in 2020 indicating a decrease of Ksh. **425,298,800/=** representing **76%**.

To deal with road carnage the Government employed measures which included strict reinforcement of the rules under the Traffic Act, 2018 and the National Transport and Safety Authority Act, 2012 and expedited prosecution of traffic offenders. Additionally, road safety campaigns were conducted using the media on proper use of the roads by the pedestrians since they were the most affected by these accidents.

3.14 Disaster

On 13th March 2020, Kenya confirmed the first case of COVID-19 in a traveler who had arrived from London a week earlier. As of 27th April 2020, there were 363 confirmed cases, 114 recoveries and 14 deaths (12 males and 2 females). There is sustained local transmission, accounting for 58% of all cases, while 42% are imported. At first Nairobi was the epicenter of the epidemic, which has now spread to 12 more counties with Nairobi and Mombasa leading with 235 cases and 93 cases respectively. To mitigate the spread within the country, the government implemented several non-pharmacological interventions: school closures, mandatory quarantines, countrywide night curfew, closure of clubs, restaurants and non-essential businesses, suspension of international flights, partial lockdowns in five hotspots (Nairobi, Mombasa, Kilifi, Kwale and Mandera) and the closure of international borders. Public service announcements emphasize policies such as social distancing by working from home, a ban on public gatherings and fewer passengers in public vehicles.

Lack of public compliance to social distancing restrictions (by defying curfew, escaping from quarantine facilities and refusal to wear facemasks) affects the efforts to suppress community transmission where in 2020 a total of 110,155 people were arrested which included 109,579 civilians, 224 security personnel, 318 civil servants and 34 politicians. The operation still ongoing. (See Appendix11)

CHAPTER 4

MEASURES TAKEN BY THE POLICE

Terrorism

The multi-agency security teams managed to detect, disrupt and deter most terror threats across the country. Arrested and prosecuted several suspects.

During the period under review, the Government put in place a number of counter-terrorism measures in a bid to stem the threat, which included the following:

- i. Enhanced capacity of security personnel through bilateral and multilateral partnerships where security personnel from various agencies received specialized counter terrorism training;
- ii. Harnessed efforts towards stabilization of Somalia to effectively deal with the threat of Al-Shabaab;

- iii. Developed County Action Plans to establish Counter Violent Extremism forums that bring together security agencies, County Governments, civil society and citizens.
- iv. Pursuing a legal framework to deliver a more robust disengagement, rehabilitation and reintegration process;
- v. Sensitized the media on terrorism reporting;
- vi. Sustained security operations and Civil Military Cooperation(CIMIC) activities in the Boni enclave;
- vii. Isolated terrorism offenders in secure blocks to avoid radicalization of other inmates in targeted prison facilities;
- viii. Enhanced engagement with the telecommunication players in a bid to check terrorism financing through mobile money transfer and communication;
- ix. Developed sensitization programs on countering terrorism and radicalization
- x. Reviewed Standard Operating Procedures (SOPs) for the multi-agency teams dealing with terrorism matters.

Intercommunal/land/boundary dispute

In addressing these conflicts, the Government undertook the following measures:

- i. Enhanced alternative dispute resolution mechanisms;

- ii. Deployed more security personnel under the multi-agency security operations approach;
- iii. Incorporated Peace Agenda in the County Integrated Development Plans (CIDPs) by establishing and operationalizing peace directorates. Some of these counties are: Turkana, Baringo, Isiolo, West Pokot, Mandera, Garissa, Marsabit and Wajir;
- iv. Facilitated establishments of county Early Warning Response (EWER) hubs alongside holding of community peace dialogues and forums;
- v. Conducted disarmament operations in Samburu, Baringo, Elgeyo Marakwet and West Pokot counties;
- vi. Sensitized communities on alternative means of livelihood; and,

Organized groups

To address this threat, the Government initiated and enhanced a number of measures which include;

- i. Intensified crackdown on the gangs.
- ii. Adoption of the multi-agency security approach.
- iii. Enhanced citizen participation in security.
- iv. Enforcement of Traffic Laws and Regulations.
- v. Establishment of the taskforce on motorcycle transport reforms.

Aliens

To address this challenge, the Government has adopted the following measures:

- i. Conducting joint operations of inland migration corridor in border control checks.
- ii. Participating in international and regional initiatives on combating illicit migration (The Khartoum Process, Global Compact on Migration, EU-Expertise France and GIZ)
- iii. Enhanced investigations, arrest, prosecution, as well as deportation of foreign nationals who are engaged in crimes.

Drugs

The Government has initiated the following measures to curb drug trafficking:

- i. Mapping of hotspots and common routes;
- ii. Restructuring the Government Chemist to create better synergy with the DCI;
- iii. Extradition of key drug barons to requesting states;
- iv. Cooperation with foreign law enforcement agencies through Mutual Legal Assistance, Memorandum of Understanding and other Agreements;
- v. Seizure and destruction of confiscated narcotics including vessels of transportations.
- vi. Follow the money approach to investigations and prosecutions.
