

CS Interior launches National Government Administration Police Unit

The Cabinet Secretary for Interior and National Administration, Hon. Kipchumba Murkomen, presided over the launch of the newly formed National Government Administration Police Unit (NGAPU) on January 24, 2025 during an event held at the Jacaranda Resort in Kwale County.

The Cabinet Secretary termed the launch of NGAPU as transformative; a move that will play a pivotal role in deterring crime and promoting community policing efforts. CS

Murkomen recognized the Administration Police Service (APS) as an invaluable component of the security infrastructure, acknowledging the Service's immense contribution to silencing the guns in the North Rift and other parts of the country.

He also commended the Administration Police Service's significant role in the fight against terrorism resulting in the stabilization of disturbed areas and securing the Kenya-Somalia border. Hon. Murkomen further expressed

confidence in the multi-agency teams conducting operations within these areas and those working all over the country to eliminate the few criminal elements conducting sporadic attacks.

"As society evolves, the Service has reinvented itself to meet the demands of time." He commended APS for continuously reworking its strategies, embracing innovation while leveraging technology which has ensured the Service's growth and adaptation to modern-day

policing. To contribute to the positive transformation, he assured that the government, through the Ministry of interior, will provide continuous support for social welfare, training, and the provision of necessary equipment ensuring that Police Officers are prepared, adequately resourced, and equipped to effectively carry out their responsibilities and meet the challenges of their roles.

He further noted that the establishment of NGAPU is one way to improve the relationship of the Service with members of public, bringing a shift from previous years where trust and communication were often strained and foster cooperation in the unified effort to eliminate crime.

The Unit's presence and proactive strategy will play a pivotal role in deterring crime and promoting community policing efforts.

PS Interior Dr. Raymond Omollo termed the launch of NGAPU as yet another nexus for collaboration, and recognized the move as an addition to the significant gains made in the Implementation of Reforms recommended by the taskforce that was led by Chief Justice Emeritus David Maraga.

NGAPU is established pursuant to Section 10(h) of the NPS Act, 2011 which authorizes the Inspector General of Police to organize the Service at national level into various formations, units or components.

Its operational strategy is anchored in cooperation with local authorities and other security agencies, forming a partnership which is essential in strengthening coordination between the Government and the public. This in turn fosters trust, ensuring a more responsive and inclusive approach to security and public safety resulting in effective service delivery.

This approach will enhance the effectiveness of law enforcement efforts, particularly in addressing issues such as conflict resolution, the eradication of illicit alcohol production, drug and substance abuse, among others.

The Unit Headquarters will be situated in Nairobi and subsidiary Formations will be at Regional, County, Subcounty, Divisional and Locational levels. It will be headed by a Commandant, who among other duties, is tasked with maintaining liaison with the respective Officers-in-charge of National Administration and Internal Security matters.

The Commandant then reports to Deputy Inspector General Administration Police Service (DIG-APS), who reports directly to the Inspector General and oversees the NGAPU's

operations, aligning its functions with national security priorities.

The Unit will be tasked with, among other roles, supporting the National Government Administration Officers (NGAO) in the management of security and the execution of their duties and responsibilities in all Administrative Units. It will also provide security during high-risk operations conducted by NGAOs. Support NGAO in conflict management and peace-building initiatives among other functions.

This familiarisation tour included an in-depth review of the National Police Service Forensic Laboratory, a state-of-the-art facility dedicated to advancing criminal investigations in Kenya.

Established in 2022, the Forensic Laboratory comprises ten specialized units, each handling different aspects of forensic science. The facility has played a pivotal role in solving high-profile crimes, including terrorism, homicide, cyber-crime, and sexual offences, equipping law enforcement with vital investigative tools.

During his address, CS Murkomen reaffirmed the government's commitment to modernising the National Police Service (NPS). He emphasised the importance of integrating advanced technology into policing to

effectively tackle the evolving nature of crime.

The Inspector General of Police, Mr. Douglas Kanja, commended the Ministry's continued support, stressing the need for inter-unit collaboration to improve service delivery. He reiterated his vision of transforming police stations into model centres of excellence in law enforcement.

The visit was attended by senior officials, including Deputy Inspector General of the Kenya Police Service (DIG KPS), Mr. Eliud Lagat, DCI Director, Mr. Mohamed Amin, Principal

Deputy to the DIG of the Administration Police Service (APS), Dr. Masoud Mwinyi (SAIG), Deputy DCI, Mr. John Onyango (SAIG), and Director of the NPS Forensic Laboratory, Madam Rosemary Kuraru (SAIG), among others.

Advancing towards a corruption-free future: NPS joins NCAJ for the launch of the Anti-corruption Strategic Guiding Framework for Kenya's justice sector

Corruption has long been a pervasive vice that severely undermines the progress of the nation. It has made its way into every corner of our society with far-reaching consequences including injustice, stifling economic growth, and eroding the public's trust in institutions.

To move our country forward, the need for change has never been more urgent. It is essential to implement structural reforms that promote transparency, accountability, and the rule of law. To set this transformative change in motion, the National Council on the Administration of Justice (NCAJ) on March 25, 2025 launched the Anti-Corruption strategic guiding

framework for Kenya's Justice Sector.

The launch marked a significant milestone in the fight against corruption, bringing together key actors in the justice Sector, renewing efforts towards a corruption-free Kenya. It is a culmination of consultative discussions made slightly over a year ago by the leaders of all arms of government agreeing to individually develop policies, guidelines and legislative proposals to speed up the fight against corruption, all channeled through the NCAJ.

The framework details long-term, short-term and medium-term strategies to address corruption and enhance

delivery of service to the public and harness public accountability.

The event was graced by Deputy Speaker Hon. Gladys Shollei who attended on behalf of the Speaker of the National Assembly Dr. Moses Wetangula. While delivering remarks on his behalf, she commended the NCAJ for living up to its mandate of facilitating holistic reforms within the justice system and ensuring a coordinated, efficient, effective, and consultative approach to the administration of justice.

The Chief Justice and President of the Supreme Court of Kenya Hon. Martha Koome termed

the launch as the culmination of the resolve to confront and root out corruption from the justice Sector. It is not only the end of the process but an urgent call to action and the beginning of a bold new chapter in the collective quest and unified efforts to integrity, justice and accountability.

Inspector General of the National Police Service Mr. Douglas Kanja on his part noted that the National Police Service plays a primary role in the fight against corruption through detection and investigation of corruption cases, financial and economic crimes. He acknowledged the critical role of collaboration among all actors in the justice sector in combating corruption. He further highlighted that by joining forces, exchanging knowledge, access to

information, and bridging gaps in expertise and resources, evidence becomes more readily available, resulting in a greater impact and promoting both diversity and inclusivity.

The National Police Service has commenced the process of digitizing all its services, and aims to automate processes such as filing of complaints, processing of fines, and other public-facing services, to eliminate opportunities for bribery.

IG Kanja further outlined measures put in place by the Service to investigate issues of corruption and economic crimes among them, the establishment of several units under the Investigation Bureau of the Directorate of Criminal Investigations (DCI) such as the Economic and Commercial

Crimes Unit, Insurance Fraud Investigations Unit, SACCO Savings and Regulatory Authority Investigations Unit, among others.

The auspicious event brought together state and non-state actors, members of the Diplomatic Corps and development partners. Also attending the event were the Attorney General of the Republic of Kenya Hon. Dorcas Oduor, President Law Society of Kenya Ms. Faith Odhiambo, CEO EACC Mr. Abdi Ahmed Mohamud, Chairperson of the Independent Policing Oversight Authority (IPOA) Mr. Ahmed Issack Hassan, Director of Public Prosecutions and Vice chair NCAJ Mr. Renson Ingonga, PS Correctional Services Dr. Salome Beacco among other senior officials.

NPS and EACC collaborate to strengthen integrity: A landmark examination into Police systems

In a bold step toward fostering integrity and eliminating corruption within the National Police Service (NPS), the Service, in collaboration with the Ethics and Anti-Corruption Commission (EACC), on February 10, 2025 launched a comprehensive examination into its systems, policies, procedures and practices at National Police College (NPC) Embakasi 'A' Campus. This initiative is meant to identify and seal loopholes that enable corrupt activities within the Service.

The event was graced by Inspector General of Police Mr. Douglas Kanja, Chairperson of EACC Dr. David Oginde, Secretary/CEO EACC Mr. Abdi A. Mohamud, as well as representatives from the European Union (EU) and the

United Nations Office on Drugs and Crime (UNODC). Senior officers of the NPS were also present, underscoring the significance of this endeavor.

Inspector General Douglas Kanja in his remarks emphasized that corruption remains a major impediment to national development, diverting resources meant for crucial sectors such as health, education, infrastructure and security. He stated that this initiative is a proactive, preventive measure aimed at reinforcing accountability and transparency within the Service.

"We recognize that corruption is not only a result of personal ethical deficiencies but also of distortions in policies, laws, and processes that create opportunities for exploitation.

By addressing these systemic weaknesses, we take a significant step toward eliminating corruption," said IG Kanja.

He further assured Kenyans that NPS remains committed to investigating and resolving all corruption-related complaints promptly and fairly, in line with Article 244(b) of the Constitution and the NPS Act.

A key component of the examination is the integration of technology in the fight against corruption. To minimize opportunities for bribery, the NPS has embarked on an ambitious digitalization agenda. Processes such as filing complaints and processing fines are being automated to reduce direct interactions that could lead to corruption.

Moreover, plans to introduce body cameras for officers during operations are underway, a move expected to enhance transparency and accountability. Other ongoing reforms include reviewing the NPS Conflict-of-Interest Policy, strengthening the Anti-Corruption Strategy, and updating the Code of Conduct and Ethics.

The IG also acknowledged the crucial role played by development partners such as the EU and UNODC under the PLEAD II Programme in supporting institutional reforms.

As the NPS continues to enhance internal oversight through mechanisms like the Quality Assurance Directorate

and the Internal Affairs Unit, IG Kanja called on all stakeholders to partner with the Service and support the fight against corruption.

"The National Police Service is dedicated to providing the highest quality of service and maintaining public trust through professionalism, accountability, and community engagement," he affirmed.

Chairperson of the EACC, Dr. David Oginde, hailed the collaboration between the NPS and UNODC, noting that it sets the stage for meaningful reforms. He clarified that the initiative is not an investigative exercise but a strategic intervention designed to improve ethical standards and service delivery.

The launch of this examination marks a pivotal moment in the history of the NPS. With strengthened policies, enhanced oversight, and an unwavering commitment to integrity, the Service is setting the foundation for a more transparent and accountable policing framework in Kenya.

As this process unfolds, all eyes will be on the NPS to ensure that these reforms translate into tangible improvements in law enforcement and public service delivery. The journey toward a corruption free police service has begun, and the stakes have never been higher.

APS launches roadmap to service delivery revitalization

The Administration Police Service (APS) on January 24, 2025 launched the APS Roadmap to Service Delivery Revitalization document for 2025-2028 at an event held at the Jacaranda Resort in Kwale County. The event themed transforming the Police to meet service delivery expectations, was organized by the Deputy Inspector General Administration Police Service Mr. Gilbert Masengeli and doubled up as the official closing of the annual APS Senior Commanders Conference.

The weeklong Senior Commanders' Conference which was officially opened by

the Inspector General of the National Police Service, Mr. Douglas Kanja on January 21, 2025, brought together senior commanders entrusted with the leadership of the APS. The event sought to facilitate a proactive response to the evolving needs of modern-day policing and ensure that policing practices are effective and meet the demands of service to the public.

During this time, the leadership of the NPS shared their perspectives with the attendees during lectures focusing on various topics including Community Policing in the 21st Century Perspective, Leadership Theories and Styles,

the Role and Mandate of the DCI in Enhancing Professional Criminal Investigations among others.

The launch of the Roadmap document which took place towards the latter part of the conference, signifies a key milestone in the Administration Police Service's advancement of law enforcement strategies, establishing a comprehensive framework for addressing evolving security challenges and fostering community engagement.

The Cabinet Secretary for the Ministry of Interior Hon. Kipchumba Murkomen presided over the unveiling of



the roadmap, noted that paired with the launch of NGAPU, the unveiling was an important milestone in the police reforms, and the implementation of the recommendations of the Chief Justice Emeritus David Maraga-led Taskforce.

This move is aligned with NPS Strategic Plan 2023-2027, and the Service's broader agenda to provide people-centric, and accountable policing services for a safer society and enhance efficiency and effectiveness in service delivery, and the APS's mission; to contribute to National development through provision of sustainable peace and tranquility to all the people of Kenya.

The Strategic Objectives of the Roadmap are to; enhance professionalism and accountability, strengthen operational preparedness and

logistical capacity, promote public trust and confidence, improve welfare and motivation of officers and support Government efforts in mitigating climate change.

Its successful execution will result in motivated Service personnel, improved operational preparedness and logistical capacity, close

working relationship with members of the public and adoption of environmentally friendly guidelines in the Service. With this Roadmap, the APS will seize available opportunities to overcome current challenges, and effectively support national security and public safety.

Renewing the fight against insecurity as Operation Maliza Uhalifu establishes second command centre

Since its inception in 2023 to date, Operation Maliza Uhalifu (OMU) in North Rift has registered significant gains in restoring peace to areas previously regarded as volatile, which have for long been affected by banditry, cattle rustling, and widespread insecurity in several counties.

Recognizing this as a national security concern, the government took decisive action to curb these criminal activities through OMU, designating these areas as disturbed and dangerous, including Baringo, Turkana,

Samburu, Elgeyo Marakwet, West Pokot, Marsabit, Laikipia, Isiolo, and Meru.

The operation's success is a result of the joint efforts of multi-agency teams comprising the National Police Service (NPS), Kenya Defence Forces (KDF), National Government Administration Officers (NGAO), National Police Reservists (NPRs), and members of the communities, all working collaboratively to eliminate security threats. It has seen the recovery of stolen livestock, rebuilding of schools and homes that were destroyed

by bandits, security agencies and the communities conduct peaceful disarmament exercises, among other gains.

In renewing these efforts and bolstering the coordinated approach, the Cabinet Secretary for the Ministry of Interior and National Administration Hon. Kipchumba Murkomen on March 27, announced the establishment of a second OMU command centre in Kirimon, Laikipia County during a security assessment visit to the County. This move is part of several other operational and

strategic interventions put in place as an assurance of the government's commitment to realizing long-term peace and stability in the region.

The new command center will expand the scope of the operation serving Samburu and Laikipia counties, and some parts of Baringo, Marsabit, Meru and Isiolo counties, complementing the first centre in Chemolingot, Baringo County which will serve Baringo, Elgeyo Marakwet, West Pokot and Turkana counties.

"The security situation in the North Rift has significantly improved, and this is attributed to the efforts of this multi-agency approach," CS Murkomen stated. He noted that the North Rift region is currently peaceful and relatively

calm, with a significant reduction in banditry incidents since the operation began.

He further assured that security agencies are actively working to eliminate the recent surge of sporadic attacks, deploying focused operations in the remaining disturbed areas of the region.

The visit to Laikipia County was preceded by others to Baringo County and Todonyang, in Turkana County, where Hon. Murkomen and the leadership of the National Police Service met security actors and local leaders during a public Baraza, where they discussed matters pertaining to security in these areas.

On his part, IG Kanja commended the multi-agency approach that was working

seamlessly well, restoring peace in areas previously unreachable. IG thanked the CS for his steadfast support and regular visits to the security teams which is a great morale boost and encouragement to the men and women in uniform.

Present during the visit were the DIG-KPS Mr. Eliud Lagat, the Regional Coordinator for Rift Valley Mr. Hassan Abdi, General Service Unit Commandant (GSU) Mr. Ranson Lolmoodoni SAIG, the Commandant Anti Stock Theft Unit (ASTU) Mr. Joseph Limo SAIG, Regional Commander Rift Valley, Mr. Jasper Ombati, AIG, Police Spokesperson Mr. Muchiri Nyaga, AIG and other senior security officers.


The success of the multi-agency model in Marsabit and Isiolo counties

One such successful multi-agency operation is 'Operation Ondoa Jangili', launched on 3rd February 2025 to root out the Oromo Liberation Army (OLA) from its hideouts in Marsabit and Isiolo counties.

OLA took advantage of the close family and cultural ties between the Borana people of Kenya and the Oromo people of Ethiopia to infiltrate and hide among the population, engaging in criminal activities such as the proliferation of small arms, illegal mining, human trafficking, cross-border incursions, and kidnappings for ransom. These atrocities have caused untold suffering to local communities.

The security team has continued to intensify raids on Oromo Liberation Army (OLA) makeshift camps, making further recoveries, including assorted firearms and ammunition, walkie-talkies, firearm holsters, counterfeit currency in US dollars and Ethiopian birr, motorcycles, motor vehicles, sacks of cannabis, food items, solar panels, generators, military

gear and caps, and Oromia literature and propaganda, among other items.

As a result of concerted efforts by all stakeholders, normalcy has been restored, as evidenced by a surge in socio-economic activities highlighting the immense achievements made by the multi-agency security team in Operation "Ondoa Jangili".

Despite these significant successes, the security team remains vigilant, working around the clock to dismantle any remaining Oromo Liberation Army (OLA)

elements and their criminal networks. As such, the National Police Service (NPS) urges the local population to continue cooperating fully with law enforcement agencies by providing vital intelligence to sustain the momentum of this multi-agency operation.

The National Police Service remains steadfast in proactively deploying intelligence-led measures to pre-empt and respond to security threats through multi-agency approaches, while upholding the rule of law and respecting and protecting human rights.

A fallen hero: The legacy of PC Samuel Tompoi Kaetuai

In the quiet village of Naserian, Kajiado County, a young boy once dreamt of soaring the skies. Samuel Tompoi Kaetuai, born in December 1994, pursued his passion for aviation at Nairobi Aviation College after excelling in his studies at Olkejuado High School. However, fate had a different plan; one that led him to a life of service, sacrifice, and ultimately, valiance.

Kaetuai joined the National Police Service (NPS) in 2021, answering the noble call to protect and serve. His dedication, discipline, and unwavering commitment to justice made him an exemplary officer. His bravery and leadership saw him become one among the first Kenyan police officers deployed under the Multinational Security Support Mission (MSS) in Haiti, a critical international effort to restore peace in a country ravaged by gang violence.

On a fateful day in February 23, 2025 during an operation to subdue a gang, PC Kaetuai was fatally shot, becoming the first Kenyan casualty in the MSS mission. News of his passing sent shockwaves through the NPS and beyond, underscoring the immense risks officers take to safeguard global peace.

As he was laid to rest, Inspector General of Police Douglas Kanja hailed him as an ambassador of peace and a hero who paid the ultimate price. MSS Force Commander Mr. Otunge also honored him, saying, "Kaetuai was a brave and noble officer who fought to protect the vulnerable. His memory will forever inspire us to continue his mission."

Though known for his valor, Kaetuai was also a devoted husband to Naomi Naneu Tompoi and a loving father to two young children, Ryan Lemayian and Talia Nashumu. His biggest aspiration was to

see them grow in a world of peace, joy, and security; the very ideals he fought for. He was also a cherished son, brother, and friend, remembered for his infectious laughter and unwavering faith.

The death of PC Samuel Kaetuai is not just a loss to his family and the NPS but to the entire nation. His sacrifice stands as a testament to the courage of those who put their lives on the line for the greater good. As the Kenyan contingent continues its mission in Haiti, his legacy remains a guiding light, reminding all of the cost of peace and the resilience of the human spirit.

His story will forever be etched in the annals of heroism and service; a son of Kenya who answered the call and never turned back.

Rest in Power, PC Kaetuai. Your sacrifice will never be forgotten.

Kenya-Re delivers on promise to support Police Officers with disabilities

When one heeds the call to serve, they step forward with bravery and resolve, fully aware of the risks inherent in their path yet driven by the noble duty of safeguarding their nation and its people. When misfortune strikes, their lives change fundamentally, and their journey takes on a new form—one that demands resilience, adaptation, strength, and support. These heroes, who bear lasting wounds, understand the true weight of sacrifice.

Yet this burden is lightened by a compassionate community, offering not only encouragement but also the practical resources needed to navigate their challenges. The Kenya Reinsurance Corporation Limited (Kenya Re), recognising these struggles, embarked on a mission to support injured officers in December last year by donating an assortment of assistive devices to the National Police Service.

Following the initial donation, a field assessment identified 73 officers in need of assistive devices and determined the specific requirements for each individual. On 13 March, the organisation fulfilled its promise by donating additional aids, including wheelchairs, hearing aids, white canes, and orthopedic shoes, among others. These essential tools were distributed to officers injured in the line of duty.

Inspector General of Police Mr. Douglas Kanja, who attended the handover ceremony, thanked Kenya Re—represented by Group Managing Director Dr. Hillary Wachinga—for honouring their pledge, a gesture reflecting their commitment to supporting officers with disabilities. He emphasised that these devices would significantly enhance mobility and restore independence for the recipients.

The Service also got support from the Accessibility Institute in Kilifi courtesy of the General Manager Mr. Charo Suleiman, who donated seven wheelchairs on March 19, 2025.

The Service was represented by Principal Deputy to the DIG-APS Dr. Masoud M. Mwinyi, SAIG, Commandant of NPC Embakasi 'A' Campus Mr. Davies Lomwatu, SAIG, Director of Gender and Welfare

at the APS Headquarters Ms. Margaret Karanja, OGW, ndc (K), AIG among other senior officers.

In his remarks, Dr. Mwinyi underscored the need to care for people with disabilities not only within the Service but also across the broader community and called for a collective effort to advocate for inclusivity and equal opportunities.

The event, held at the National Police College Embakasi 'A' Campus, was attended by representatives from Maendeleo ya Walemavu.

The NPS appreciates the support of all stakeholders, which has been essential in driving meaningful change as we work towards a more inclusive society where all persons have the opportunity to thrive.

Horace Mann, an American educational reformer regarded as the "Father of American Education" for his commitment to promoting public education, once said, "Education then, beyond all other devices of human origin, is the great equalizer of the conditions of men, the balance wheel of the social machinery." Similarly, Nelson Rolihlahla Mandela, the first President of South Africa,

stated that "Education is the most powerful weapon which you can use to change the world."

These words are perfectly embodied by Chief Inspector (CI) Isaac Njiraini Muhia, who is currently serving at the Directorate of Corporate Communication, National Police Service Headquarters, Jogoo House 'A'. He was recently awarded a Gold Medal

for attaining first position in order of merit in his Master of Arts in Journalism and Mass Communication programme at the Central University of Punjab's School of Information and Communication Studies.

He received the award during the university's graduation ceremony, which was held in Bathinda, Punjab State, India, on 11 March 2025. The event was presided over by the Honourable President of India, Smt. Droupadi Murmu ji.

CI Njiraini is the first international student of African descent to receive the Gold Medal in the history of the Central University of Punjab. This is no mean feat. It has brought honour, glory, and pride to the National Police Service and to Kenya.

His thesis focused on Health Communication, particularly misinformation in prostate cancer. Misinformation affects patient decisions and trust in medical professionals.

Similarly, misinformation is a major problem in law enforcement, where unverified claims, false information, distorted facts, and social media speculation shape public perception of the police in Kenya, undermining public confidence and affecting officers' morale.

The research on misinformation underscores the need for proactive communication strategies, such as community

engagement and evidence-based interventions, to ensure that accurate information reaches the public, fostering trust in law enforcement.

Additionally, during his time at the university, CI Njiraini served as a Foreign Delegate Member in the 16th National Youth Parliament (NYP) of India. He participated in the NYP's annual competition, organised to foster democratic values, encourage public speaking, and enhance parliamentary awareness among students. The Central University of Punjab won first place, becoming the National Champion.

He undertook the course through the Indian Council for Cultural Relations (ICCR) Scholarship Scheme, a government institution that promotes cultural exchange between India and other countries. CI Njiraini sincerely appreciates the National Police Service and the Government of India for the opportunity to pursue this degree.



Located approximately 5 kilometers from Gilgil town and next to the Anti-Stock Theft Unit headquarters, the Academy rests on 100 acres of lush greenery, recently augmented by the 13-acre Peace Garden. This iconic

academy has moulded some of the brightest minds, who are making remarkable contributions to different fields such as engineering, medicine, technology, art, and many others.

Derived from the Kenya Police Service motto, "Utumishi kwa Wote" (Service to All), the academy shares a deep affiliation with the Kenya Police Service, whose staff and leadership envisioned a stable educational institution for their children.

Hail the track queen: Celebrating CPL Beatrice Chebet's journey to stardom

In the world of long-distance running, world record holder Corporal Beatrice Chebet is a force to be reckoned with. Born in March 2000, Beatrice spent her childhood in Londiani, a small town nestled in the rolling hills of Kericho County, Rift Valley region, which is known as the hub of athletic talent in Kenya. The gifted speedster discovered her talent while still in primary school, nurturing it all the way through high school at Saramek Secondary School in Londiani.

Driven by a desire to reach new heights and the unwavering encouragement of her grandmother, she launched her professional career in 2016

when she joined Lemotit Athletics Club, marking the beginning of a journey to conquer her dreams and realise her vision of becoming one of the greats.

In 2018, in what she considers one of her most memorable wins, the then 18-year-old Chebet triumphed in Tampere, Finland, taking home her first gold medal in the World Athletics Under-20 Championships in the 5000-metre race. The soft-spoken athlete has not looked back since, rising to prominence and establishing her place as a force in the athletics world.

In April 2022, she was enlisted

into the National Police Service, completing her training at the National Police College Main Campus in Kiganjo and passing out in January 2023. The rigorous training equipped her with the requisite skills to maintain law and order, detect and prevent crime, in addition to enhancing her athletic ability. At the culmination of her training, she took an oath for love of country, making a noble commitment to serve and protect.

The National Police Service played a crucial role in her journey, granting her the opportunity to train and compete while still in service. In 2022, she had the opportunity

to compete in several regional and international events, with her most significant wins that year being the gold medal in the women's 5000m during the Diamond League finals in Zurich, Switzerland and first place in the women's 5000m final during the Commonwealth Games at the Alexander Stadium in Birmingham, England. She started 2023 on a high note, winning gold at the World Athletics Cross Country Championships in Bathurst, Australia, and then went on to secure bronze in May after taking third place in the Women's 5000m Final at the World Athletics Championships held in Budapest. On the last day of 2023, a determined Chebet set a new women's world 5km record with a time of 14:13 at the Cursa dels Nassos in Barcelona, Spain.

Among her accomplishments, she made her debut in the Olympic Games last year in Paris, France, where she clinched double gold in the

5000m and 10,000m races, becoming the first Kenyan woman to win an Olympic 10,000m title. Her victory in the action-packed 5000m race was

no mean feat, as she beat her compatriot, household name, and fellow world champion Faith Kipyegon, who took home the silver medal.

Upon her return from Paris, in recognition of her outstanding performance, she was promoted to the rank of Corporal by the then-Acting Inspector General, Mr. Gilbert Masengeli.

She also set a new world record in the same year, running an impressive 13:54 in the women's 5km race, smashing her own record set the previous year and becoming the first woman to break the 14-minute barrier for the distance on the track. She also won the women's 5000m heat for the second time during the Diamond League finals in Zurich, Switzerland.

She has received numerous awards and accolades in recognition of her achievements, among them the prestigious Golden Plate Award at the American Academy of Achievement which recognizes the exemplary performance of individuals in various fields.

At home, she was fêted as the first runner-up for the Sportswoman of the Year award during the 2023 Sports Personality of the Year Awards (SOYA Awards), an annual event that recognises outstanding performers in the Kenyan sports industry. The remarkable Chebet is also a recipient of the Order of the Grand Warrior (OGW), an award presented to individuals in recognition of

outstanding service rendered to the country in various capacities.

Nicknamed "the smiling assassin," Chebet is the embodiment of grit, resilience, and passion. Her fierce determination is matched by her grace and does not detract from her good nature and kind spirit. She attributes her success to discipline and aspires to mentor and empower other athletes, making their journeys easier. She currently trains under the steady guidance of her coach and husband, Peter Bii, whom she acknowledges for his support in refining her technique and motivating her to achieve even greater success in her career.

Truly, Chebet has proved to be a force and one to watch in the athletics world, conquering her races with unfaltering determination. Each sure step brings her closer to the finish line, charting her path with incredible courage and rising to unbelievable heights, living true to the words of Michelle Obama: "There is no limit to what women can accomplish."

Her success is not only a personal achievement but also a testament to the power of consistency, resilience, and determination. It is a motivation



that not only opens up a world of limitless possibilities but also serves as a guiding light to others who aspire to reach even greater levels of success.
